Please take notice that the Agricultural Labor Relations Board (ALRB or Board) will hold a public meeting on Wednesday, June 26, 2024, at 10:00 a.m. at 1500 Capitol Avenue, Hearing Room 72.167, Sacramento, CA 95814.
